Council member Vaughn seconded the motion and it passed all ayes with record vote as follows: Vaughn, Adams, Geisinger. Nays: none. Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 23-3-2 for the record.

Council member Geisinger moved to approve Wilson's Tap liquor license. Council member Adams seconded the motion and it passed all ayes.

Council member Vaughn moved to approve Darci Judge to the Colo Library Board. Council member Adams seconded the motion and it passed all ayes.

Council member Geisinger moved to approve Mindy Buechel to the Colo Library Board. Council member Vaughn seconded the motion and it passed all ayes.

City attorney was tabled. Discussions on the housing development were had.

There being no further business to come before the meeting, Council member Adams moved to adjourn. Council member Vaughn seconded the motion. The motion carried and the meeting adjourned.
